Fr. Bill Writes

This past week saw all our Schools and Colleges reopen after the Easter Holidays 2024. Work has begun across the Shrewsbury Diocese to make sure that all Primary as well as Secondary Schools are part of an Academy Trust. This will involve a great amount of work for Governors and the Diocesan Education Department, in cooperation with Local Education Authorities across the Diocese. We wish all involved in this project success, as it is a complicated and time consuming process. The Diocese of Shrewsbury will in the near future be advertising for a new Director of Education as Mr. Cunningham, the present diocesan director is due to retire. Interviews prior to Christmas for a Property Director to replace Richard Crawford, the current director were unsuccessful, Richard will remain in post until a new director is appointed. The Diocese of Shrewsbury is similar to any PLC Company in the way that it operates, and so it must have the most qualified people leading the various departments operating within the diocese.

Lancaster Maloney Martin Architects, have come back with their recommendation of a suitable tender, for the front of Church and Car Park project, Kestrel Interiors Ltd are their recommendation as the most suitable tender. I await to hear the recommendations of the diocesan property manager, with regard to our next step. The tender which also includes Vat and professional fees comes to 140k most of which we have. We still need approximately 20k to complete the project, so now we need to up our fundraising. Thanks to those who have taken a new set of Monthly Development Fund envelopes as well as to those who have Standing Orders and to those who use the Contactless Plate which can also be used to donate to the Parish Development Fund. It will make a great difference to the frontage of the Church and Parish Meeting Room when the new entrance and windows are fitted, and the front car park is resurfaced. The front of the Church and car park has a very tired look about it at the moment.

This coming week there will be no daily Mass on Wednesday 24th April, Fr. Stephen will be attending the Diocesan Junior Clergy Gathering with the Bishop. Thanks again to Fr. Stephen for his Priestly Ministry at Holy Spirit and St. Bernadette's and to all who are continuing to volunteer in Fr. Bills enforced absence.

SCRIPTURE READINGS — Fourth Sunday of Easter (Good Shepherd Sunday) Acts 4: 8-12 1 John 3: 1-2 John 10: 11-18
